- 1. The Candidate appointed to the post of Pilot will undergo training for a period of 6 months and will be designated as Trainee Pilot. On obtaining the license after training, he/she will be designated as Pilot.
- 2. In addition to Basic pay, benefits like DA on industrial pattern, accommodation / HRA, Cafeteria allowance, NPS, Group Insurance, Medical facilities, Encashment of earned leave, etc, admissible as per Rules along with applicable Marine allowances.

#### General Instructions / Conditions:

- 1. While applying for the post, the applicant should ensure that he / she fulfills the eligibility and other norms mentioned above. In case, it is detected at any stage of recruitment that a candidate does not fulfill the eligibility norms and / or that he / she has furnished any incorrect / false information or has suppressed any material fact(s), his / her candidature will stand automatically cancelled.
