Similar work means Experience in fabrication and repair work of buoys, pipelines, Metal structures, hull plates of ships, boats and launches.

2.3.1 Average annual financial turnover of the tenderer should not be less than ₹2,20,832 during the last three financial years ending on 31.03.2024. The details shall be furnished in Annexure XIV. A copy of the auditor's report along with balance sheets for the past three years should be enclosed along with the tender.

2.4 Evaluation and comparison of tenders:

4.1 Scope of the Tender:

Offers are invited from the bidders for the work "Reconditioning of 05 Navigational Channel Marker Buoys" for the Marine department. The buoys shall be handed over in a fully operational condition acceptable by the Port officials on completion of works as stipulated in the 5.1 of Section 5 scope of work.

4.2 DEFINITIONS AND INTERPRETATIONS:

In the contract, as hereinafter defined the following words and expressions shall have the meaning hereby assigned to them except where the context otherwise requires.

4.2.1 Definitions:

- (a) Contract elements: -
 - (i) "Contract" means the Contract /Agreement for the supply of goods and provision of services entered into between the Employer and the Contractor, as recorded in the Contract Form signed by the parties together with the Contract Documents and appendices referred to therein.
 - (ii) "Contract Documents" means the documents specified in the Form of Contract/ Agreement (including any amendments to these Documents).
 - (iii) "Contract Agreement" means the agreement entered into between the Employer and the Contractor using the Form of Contract Agreement contained in the Tender Documents and any modifications to this form to be agreed by the Employer and the Contractor.
 - (iv) "Contract Price" means the sum named in the tender subject to additions thereto or deductions therefrom as may be made under the provisions hereinafter contained.
 - (v) "Tender Documents" means the collection of documents issued by the Employer to instruct and inform potential Contractors of the processes for Tendering, selection of the winning Tenderer, and contract formation, as well as the contractual conditions governing the relationship between the Employer and the contractor.
 - (vi) "Tender" means the Contractor's priced offer to the Employer for the execution and completion of the Works and the remedying of any defects therein in all accordance with the provisions of the Contract, as accepted by the Letter of Acceptance Work Order.
 - (vii) "Bill of Quantities" means the priced and completed Bill of Quantities", forming part of the Tender.
 - (viii) "Specification" means the specification of the Works included in the Contract and any modification thereof or additions thereto made or amendments thereto as may be from time to time be furnished or submitted by the Contractor and approved by the Employer.

- (ix) "Letter of Acceptance"-"Work Order" means the formal acceptance by the Employer of the Tender.
- (x) "Schedules" referred to in these conditions shall means the relevant schedule (s) annexed to the tender papers issued by Employer.
- (xi) "Approved" means approved in writing including subsequent written confirmation of previous verbal approval and "Approval" means approval in witting including as aforesaid.

(b) Entities:

- (i) "Employer" means the Board of Authorities of V.O.Chidambaranar Port Authority or their successors and assigns, acting through its Competent Authority or any other officer so nominated by the Board.
- (ii) "**Project Manager**" means the person appointed by the Employer to perform the duties delegated by the Employer (Deputy Conservator), Marine Department V.O.Chidambaranar Port Authority.
- (iii) "Contractor" means the person or persons or firms or company or vendor or contractor whose Tender has been accepted by the Employer and the legal personnel representatives or the successors of such firm or vendor and the permitted assigns of such persons.
- (iv) "Contractor's Representative" means any person nominated by the Contractor and named as such in the Contract /Agreement and approved by the Employer to perform the duties delegated by the Contractor.
- (v) "Subcontractor" including vendors, means any person to whom any of the obligations of the Contractor, including preparation of any design or supply of any accessories or other Goods or Services, is subcontracted directly or indirectly by the Contractor with the consent of the Employer and the legal successors in title to such person.
- (vi) "Board" The Board means the Board of Major Port Authority of V.O.C. Port Authority, an autonomous body constituted by the Central Government in accordance with Sub-section (1) of section 3 of the Major Port "Authorities Act 2021 as amended from time to time.
- (vii) "**Engineer**" means the Chief Mechanical Engineer of the V.O.Chidambaranar Port Authority and his successors.

(c) <u>Scope: -</u>

"Reconditioning of 05 Navigational Channel Marker Buoys" for the Marine department.

(d) Activities:-

(i) "Leak Testing" means all the buoys to be floated in the sea and buoyancy to be tested for its proper functioning.

(e) Place and time: -

- (i) **Project Site(s)**" means the place(s) (Navigation section) where the defective buoys are stationed.
- (ii) "Time for Completion" means the time for completing the execution and complying with and fulfilling the requirements on Completion of the Works or as extended calculated from the Commencement Date.'
- (iii) "A day" means a day 24 hours from midnight to the next midnight irrespective of the number of hours worked on that day.
- (iv) "A week" means seven days without regard to the number of hours worked on any day in that week.
- (v) "A month" means month according to Gregorian Calendar.
- (vi) "**Urgent works**" Shall mean any urgent measures which in the opinion of the Engineer-in-charge become necessary during the progress of the works to obviate any risk of accident or failure or which become necessary for security.
- (vii) "Warranty Period" means the period of warranty given by the Contractor commencing at the date of the Operational Acceptance Certificate of the buoys complete during which the Contractor is responsible for defects with respect to the buoys & its associated parts and for remedying it at the cost and risk of the Contractor.
- **4.3** On receipt of this tender document, the tenderers are advised to study the technical details, commercial terms, and conditions of the tender. - (iii) After getting the required technical/ commercial clarifications, if any, based on the information given in the technical bid, the tenderers will be prequalified based on the uploaded documents submitted by them and proof of concept for the scope of work as proposed in the tender.
- (iv) The work completion certificate should be enclosed with the document. If the work completion certificate furnished is from other than Govt. Departments by the bidder/tenderer to fulfil the requirement of Minimum Qualification Criteria, the same shall be supported with a TDS certificate (FORM–16 A) issued by the Company/agency where the work was executed for the full executed amount of the work otherwise such work experience shall not be considered.
- (v) The price bid of the pre-qualified tenderers alone will be opened by etendering procedure on a subsequent date. The decision of the Port Authority in pre-qualifying the eligible tenders will be final.
- (vi) The V.O.Chidambaranar Port Authority shall have no liability to the tenderer in respect of any expenses incurred by him, direct or indirect, in preparing and/or uploading the tender.
- (vii) Price bid of the bidders satisfying the above prequalification criteria will be opened and L1 will be decided on the lowest total amount excluding GST.
- **4.8.1** After pre-qualifying the tenderers based on the evaluation criteria and the documents uploaded in the Technical bid, the Price bid submitted by the pre-qualified tenderers alone will be opened on a subsequent date to be notified in the e-tendering portal and Port website. The decision of the Port Authority in pre-qualifying the eligible tenderers will be final.
- **4.9** The forms of tender, schedules, conditions of contract, etc., shall not be defaced or detached from the documents.
- **4.10** Language of the tender: The tender submitted by the tenderer and all correspondence and documents relating to the tender exchanged by the tenderer and the V.O.Chidambaranar Port Authority shall be in English language. Any printed literature, other than in the English language shall be accompanied by an English translation, in which case, for the purpose of interpretation of the tender, the English translation shall govern.
- **4.11 TDS CERTIFICATE**: Bidders who carried out work under private organizations have to upload Form 16A for the proof of deduction of TDS.

4.12 PERFORMANCE SECURITY:

- (i) The contractor shall deposit an amount equal to 5% of the accepted tender value as Performance Security shall be paid through RTGS /NEFT to V.O. Chidambaranar Port Authority, Tuticorin or irrevocable Bank Guarantee (Physical/SFMS Mode) obtained from the Nationalised / Scheduled Commercial bank having a net worth of above ₹100 crores having its branch at Tuticorin and payable at Tuticorin, in the form as per specimen in Annexure-VII.

- (iii) A letter from the Bank shall also be sent along with the Bank guarantee directly to the Employer within 15 days of placement of the work order or before the commencement of work whichever is earlier. However, the Deputy Conservator may relax the time limit of 15 days and extend it by a further period of 10 days in extraordinary circumstances for the reasons recorded by him. If the performance Security is not deposited in time as prescribed above, the work order shall stand cancelled automatically and the bidder will be suspended for a period of one year. The performance security will remain in force throughout the period of the contract of tender as specified in the tender document of this tender and including three years warranty period and will be refunded thereafter.
- (iv) The contractor shall furnish the BG towards performance security by the issuing bank directly to the port. The amount as stated will not bear any interest. Bank Guarantee, obtained from the Nationalized Bank /Scheduled bank in the format prescribed by the Port, shall be in compliance with a digital confirmation for the Bank Guarantee and the BG not complying with this shall not be considered.
- (v) The Bank Guarantee shall be refunded without any interest after the successful completion of the contract. If the contractor fails to perform or observe any of the conditions of the contract, Port Authority will be at liberty to deduct any amount due to Port Authority under this contract from Security Deposit / any sums of money due or that may become due to the Contractor. This is without prejudice to the rights of the Port Authority under the terms of this Contract.

- (vi) The Bank Guarantee furnished towards the performance security shall be valid up to the completion of the warranty period and shall have a claim period of three months after the successful completion of the warranty period. In case of extension of the warranty period, Bank Guarantee has to be extended for a further period as required by V.O. Chidambaranar Port Authority to cover the warranty period. Any expenditure in this regard will be borne by the contractor.
- (vii) Performance Security may be furnished in the form of Insurance Surety Bonds, Account payee Demand draft, Bank Guarantee from a Commercial bank (SFMS Mode) or deposit to VOC Port Account, in an acceptable form safeguarding the purchaser's interest in all respects.

4.13 **SECURITY DEPOSIT:**

Security Deposit will be deducted from the bill after adjusting the amount already deposited by the contractor as Performance Security subject to a maximum accumulation of 5% of the contract price. The amount is held in deposit as a security for satisfactory completion of the work including the further extended period of Work. The Security Deposit will remain in force throughout the warranty period of 6 months, and will be refunded after satisfactory completion of work. The Security Deposit will not bear any interest.

4.14 COMPLETION PERIOD:

The time allowed for "Reconditioning of 05 Navigational Channel Marker Buoys" for the Marine department. including the time for the leak test shall be 60 days from the date of award of the work order. However, the Contractor should make all efforts to complete the work as early as possible. If the work is not completed within the stipulated time, liquidated damages as per clause 4.37 will be applicable.

4.15 RATES TO BE FIGURES AND WORDS:

The tenderer shall quote the rate in Indian Rupees and in English, in figures as well as in words, the rates tendered by him in the concerned proforma of the tender and in such a way that interpolation is not possible. The tendered amount for the work shall be entered in the tender form and duly signed by the tenderer. In case of any discrepancy between figures and written words, the rates in words shall be taken as the quoted price.

4.16 PRICE:

The tenderer shall quote specific rate for all the work as stipulated in the **5.1** of Section 5 scope of work in the scope of work in the Price Schedule and the rate should be in Indian Rupees. The rate should be legible both in figures as well as in words for each item and in such a way that interpolation is not possible. In case of any discrepancy between the figures and written words, the rates in words shall be taken as the quoted price. The quantities indicated in Schedule-A are tentative and the Port reserves the right to modify the quantities specified in Schedule-A, based on the requirements as on the date of award of contract.

(i) Tenderers should not send any revised or amended offers after the last date and time for receipt of tender.

4.17 TAXES AND LEVIES:

- (i) The rate quoted by the Bidder is exclusive of GST. Applicable GST to be shown separately in Tax Invoice and same will be reimbursed. All the GST returns needs to be filled within time limit. The contractor shall file the applicable returns with Tax Department in time and submit the same as documentary evidence. Input Tax credit lost if any due to non-filing of returns will be recovered from contractor.
- (ii) After the last date of bid submission date, other than GST if any new taxes, levies, duties imposed by the Govt. is applicable to this contract, same shall be reimbursed by the employer on production of documentary evidence.

4.18 CORRECTION/ VARIATIONS ETC.

- (i) All corrections and alterations in the entries of the tender documents shall be attested with full signature of the tenderer with date. No erasures or overwritings are permissible.
- (ii) The tenderers should not send any revised or amended offers after the opening of the tender. No such document will be entertained. The Board also do not accept offers with the price variation clause.
- (iii) The prices and amounts entered in the schedule of price shall represent the tenderers offer for the work generally in accordance with work specifications and purpose given in this tender.

4.19 **DEVIATION**:

The tender should be completed in all respects for taking a decision immediately on the opening of the tender. In the absence of Tenderer's disagreement to any particulars clause, it will be construed that they are agreeable to such port's conditions where they have not expressly deviated.

4.20 SIGNING OF TENDER:

- (i) The tender shall be signed only by the parties who are themselves in a position to undertake the work and possessing all other resources required for the purpose. The tender shall contain the name, residence and place of business of the person or persons submitting the tender and shall be signed by the tenderer with his usual authorized representatives followed by the name and designation of the person signing the document along with a copy of the partnership deed. Tender by a corporation shall be signed in the name of the corporation by a duly authorized representative, and a power of attorney on that behalf shall accompany the tender. A copy of the constitution of the firm with the names and addresses of all the partners shall be furnished. In the case of the company, a copy of the Memorandum and Articles of Association shall be furnished.
- (ii) Tenders may be submitted by agents on behalf of their principals, but in such cases, the Board reserves the right to enter into a contract with the principal's director with the principals and agents jointly as deemed appropriate.

4.21 WITNESS:

Witness shall be persons of status and property and their names, occupations, and addresses shall be furnished below their signatures.

4.22 ALL PAGES TO BE SIGNED:

All signatures in the tender documents shall be dated. All pages of all sections of the original and duplicate tender documents shall be signed with date and seal at the lower right hand corner and wherever required in the tender documents by the tenderers or by a person holding power of attorney to sign on behalf of the tenderer before submission of the tender.

4.23 RIGHT OF THE BOARD TO ACCEPT OR REJECT THE TENDER:

The Board does not bind itself to accept the lowest tender and reserves the right to reject any or all the tenders received without assigning any reason whatsoever. Tenders in which any of the particulars and prescribed information are inadequate or incomplete in any respect or the prescribed conditions are not fulfilled are liable to be rejected. Canvassing in any form by the tenderers will result in their tender being rejected.

4.24 TRANSFER OF TENDER DOCUMENTS:

Transfer of tender documents by one intending tenderer to another is not permissible.

4.25 OPENING AND ACCEPTANCE OF TENDER:

- (i) Techno-commercial Bid will be opened at 1630 hrs **on** _____ in the e-tender portal https://etenders.gov.in/eprocure/app. Tenderers can witness the tender opening by logging in to the e-tender portal at the date and time fixed for the tender opening.
- (ii) Tenders submitted by tenderers shall remain valid for acceptance for a period of 120 days from the date of opening of the tenders. The tenderer will not be allowed during the declared period of validity to revoke or cancel his tender or to vary any term thereof, without the consent in writing of the Deputy Conservator, V.O. Chidambaranar Port Authority.

4.26 ADDENDA/CORRIGENDA:

- (i) Addenda/Corrigenda to the tender documents will be issued by the Deputy Conservator, V.O.Chidambaranar Port Authority prior to the date of opening of the tenders, to clarify or reflect modifications in the contract terms and conditions.
- (ii) Such addendum/corrigendum will be published in the e-tendering portal and also in the VOC Port website too. Tenderers who are unable or unwilling to bring their tenderers to confirm to the requirements of the Board are liable to be rejected.

4.27 COLLECTION OF DATA - TENDERER'S RESPONSIBILITY:

The tenderer shall visit the site and acquaint himself fully with the site and local conditions and no claims whatsoever will be entertained on the plea of ignorance or difficulties in the execution of the work. Before submitting the tender, the tenderer shall be deemed to have clearly understood and satisfy himself regarding the work and services, all conditions liable to be encountered during the execution thereof and that prices, rates and/or compensation quoted in the offer are adequate and all-inclusive with respect to all factors, circumstances and conditions likely to be incidental, both direct and indirect, to the work and services. The prices and amount quoted by the tenderer shall allow for all costs, including escalation of labour, transport, insurance fees, increase in cost due to government and other charges, direct and indirect, till the work is completed in accordance with the scope of the contract and contract period.

4.28 AMBIGUITY:

Should there be any ambiguity or doubt as to the meaning of any of the tender clauses/conditions or, if any further information is required, the matter should immediately be referred to the Deputy Conservator, V.O. Chidambaranar Port Authority in writing, whose interpretation shall be final and binding.

4.29 TENDERER'S COMMENTS:

Any comments that the tenderer desires to make shall not be placed in the annexed documents but shall take the form of a separate statement in the English language and giving reference to page, clause or item numbers and shall be submitted along with the tender

4.30 SIGNING THE CONTRACT:

The successful tenderer shall be required to execute an agreement in the proforma prescribed by the V.O. Chidambaranar Port Authority (draft enclosed as Annexure-VI) on Tamil Nadu Government State stamp paper of the required value within 15 days from the date of issue of the notice of acceptance of the tender. In the event of failure on the part of the successful tenderer to execute the agreement within the above stipulated period, or the period agreed by the Port, the performance security or Security Deposit deposited by him will be forfeited and apart from that the Board being in such circumstances entitled to treat the successful tenderer as in breach of contract and proceed accordingly.

4.31 EXTENSION OF TIME:

- (i) The Contractor shall commence the works on site with the period named in the tender after the receipt by him of an order in writing to this effect from the Engineer and shall proceed with the same with due expedition and without delay expect as may be expressly sanctioned or ordered by the Engineer or be wholly beyond the control of the contractor.
- (ii) The contractor shall maintain the rate of progress required as per schedule if the progress of work is held up owing to circumstances, which in the opinion of the Engineer are beyond the control to the contractor such as war stormy, weather and for other reasonable causes in the opinion of the Engineer may at his discretion, grant to the work in such extension of time as he considers reasonable for the completion of the work. In such

circumstances, the contractor shall apply for extension of time within fifteen days of the hindrance on account of which he desires such extension aforesaid. The execution of the work during the extended period also shall be only under the conditions and at the rates specified in the contract.

(iii) No claim shall be made by the contractor on the grounds of executing the work beyond the completion period stipulated in the contract.

4.32 DETERMINATION OF RESPONSIVENESS:

The tender which does not satisfy the terms and conditions as mentioned in the tender, shall summarily be rejected and shall not be considered for further evaluation. The owner will scrutinize tenders to determine whether the tender is substantially responsive to the requirement of the tender document. For the purpose of this clause a substantially responsive tender is on which inter-alia confirms to all the terms and conditions, general conditions of the entire tender documents without any deviation (or) reservation. A tender which in relation to the estimated rates, is un-relating will be rejected as non-responsive. The decision of the owner shall be final in this regard.

4.33 TESTING:

After completing repair of the Buoys and accessories, the tenderer shall carry out the necessary leak tests in the presence of the Deputy Conservator, Marine Department, V.O.Chidambaranar Port Authority. Any defects during the tests, trials shall be made good by the tenderer at his own expense. All arrangements and expenses to carry out the leak test is of contractor's scope. In the case of differences regarding tests, the decision taken by the Port Authority shall be final and binding on the tenderer. On completion of the tests and trials to the entire satisfaction of the Deputy Conservator or any officer authorized by the Competent Authority in this behalf, a performance certificate will be issued by VOCPA and the same to be submitted along with the bill for the subject work.

4.34 WARRANTY

Warranty period shall be 6 months, in the event of any defect or deficiency being discovered in any part of the buoys, or fittings, which is attributable to defective materials, design or workmanship of buoy during the warranty period, the tenderer shall immediately make good the same at his own cost. The tenderer shall supply materials or equipment or goods to replace those proved to have been so defective at his own cost. The cost of all replacements of such defective parts and those affected by such defective parts or materials including freight, insurance, statutory levies and delivery charges etc as applicable, shall be borne by the tenderer who will also at his own cost arrange for the fitting and installation of the replacement parts. If the contractor does not respond to warranty claim within seven days of intimation of defect, the warranty period of the same shall be extended beyond the normal period by such period, not exceeding the period of idleness, as the Deputy Conservator, V.O. Chidambaranar Port Authority will decide.

4.35 PENALTY DURING WARRANTY PERIOD:

During the warrantee period, the contractor should complete the defects of buoys within 72 hours from the time of receipt of calls from the user department. If the complaints cannot be rectified within 72 hours, penalty would be imposed based on

the downtime of hours, an amount of ₹100/- would be recovered as penalty for every hour of down time beyond the admissible 72 hours.

4.36 TERMS OF PAYMENT:

100 % payment would be made within 30 days after the completion of "Reconditioning of 05 Navigational Channel Marker Buoys" for the Marine department. for the Marine Department. However the security deposit will refunded after the completion of warranty period.

4.37 LIQUIDATED DAMAGES:

- (i) If the tenderer fails to commence the work within the period specified vide clause 4.14 or within such extended time that may be allowed by the Competent Authority, the tenderer shall pay or allow the Board to deduct the sum equivalent to 1 % of the value of the materials not supplied per week (7 days) or part thereof for the period of such delay subject to a maximum limit of 10% of the tender value as liquidated and ascertained damages and not by way of penalty and such damages shall be deducted by the Port from any money due to or to become due to the tenderer.
- (ii) Except in case of force majeure, as provided under clause 4.14, delay by the contractor in the performance of its completion of obligations shall render the contractor liable to imposition of liquidated damages pursuant to clause.

4.38 FORCE MAJEURE:

- (i) Either party here to shall be held responsible for any delay/failure to perform any or all of the obligations imposed upon such party caused by Force Majeure. In such a case, the time for performance of such obligations of the other party, to the extent that they are directly or indirectly affected by such occurrence, will be extended by a period equal to that time.
- (ii) Notification of a circumstance of Force Majeure shall be given by Fax/email addressed to the Port within 10 working days of its occurrence. This Fax/e-mail shall be confirmed by letter dispatched within 4 week along with a certificate from the relevant Chamber of Commerce, confirming the existence of the circumstance of the Force Majeure.
- (iii) Only the following shall be considered as Force Majeure if they intervene before commencement date and impede performance. Acts of God, war, revolutions, fire, floods, epidemics, quarantine restriction, freight embargoes and acts of State (excluding power cuts). However, should such a delay even if due to reason of Force Majeure be protracted for more than three 3 (months), V.O. Chidambaranar Port Authority may cancel the contract, subject to the consent of the Contractor, at no charge to V.O. Chidambaranar Port.

4.39 VALIDITY:

Tenders submitted by tenderers shall remain valid for acceptance for a period of 120 days from the date of opening of the tenders. The tenderers will not be allowed during the declared period of validity, to revoke or cancel his tender or to vary any terms thereof, without the consent in writing of the Deputy Conservator, V.O. Chidambaranar Port Authority. All statutory approvals are in the contractor's scope.

4.40 FORMATION OF A CONTRACT:

The work order on its acceptance by the tenderer will form a contract. The selected tenderer should enter into an agreement in the specific Format on ₹100/- non judicial stamp paper at the cost of the tenderer.

4.41 DISPUTE RESOLUTION:

In case of any dispute regarding the contract, the decision of the Competent Authority, V.O. Chidambaranar Port Authority will be final.

4.42 LEGAL JURISDICTION:

No suits for any proceeding in regard to any matter arising in any respect under this contract shall be instituted in any court save in the city civil courts of Tuticorin. It is agreed to that no other court shall have jurisdiction to entertain any suit or proceedings, even though part of the cause of action might arise within their jurisdiction. In case of any dispute, the decision of the Competent Authority, V.O. Chidambaranar Port Authority is final.

4.43 CHANGES IN CONSTITUTION OF FIRM:

In the case of a tender by partners, any change in the constitutions of the firm shall be forthwith notified by the Contractor to the Deputy Conservator, V.O. Chidambaranar Port Authority for his information.

4.44 INSPECTION OF SITE:

The tenderer is advised to visit the site before submitting their offers in order to ascertain the nature of work involved.

4.45 LABOUR:

- (i) The contractor shall get the gate entry pass (ie, temporary ID card) for their engineers and labours on their cost.
- (ii) The contract labourers / employees shall display their identity card while inside the Port area.
- (iii) The contractor shall furnish the personal particulars of their labourers / employees. Also the contractor shall give an undertaking for the good contract of their labourers / employees inside port area.
 - The contractor shall allow his labourers the government notified national and local festival holiday and also such closed holidays for the Port declared by the employer and also have due regard to local religious and social customs in respect of labourers employed by him.
- **4.46** Any penal interest, penalty or fine payable / paid by the contractor to the Tax Authorities on the taxes shall not be paid / reimbursed by the V.O. Chidambaranar Port Authority under any circumstances.
- **4.47** In the event, the tenderer not indicating the rate of taxes and duties separately in the bid, Port shall not pay for any change in the rate of taxes and duties

including any newly levied taxes and duties during the entire currency of the contract under any circumstances.

4.48 CONTRACTOR TO INFORM HIMSELF FULLY: The contractor shall be deemed to have carefully examined the general terms and conditions of contract, technical specifications, and form of tender and informed himself fully regarding the conditions in which the contract is to be executed, the rules and regulations and all other matters and things affecting the cost for the subject work and satisfied himself fully regarding the sufficiency of his tender to cover all his = obligations under the contract.

4.49 GOODS AND SERVICES TAX:

The rate quoted by the Bidder is exclusive of GST. Applicable GST to be shown separately in Tax Invoice and same will be reimbursed. All the GST returns needs to be filled within time limit. The contractor shall file the applicable returns with Tax Department in time and submit the same as documentary evidence. Input Tax credit lost if any due to non-filing of returns will be recovered from contractor.

After the last date of bid submission date, other than GST if any new taxes, levies, duties imposed by the Govt. is applicable to this contract, same shall be reimbursed by the employer on production of documentary evidence.

- **4.50 INCOME TAX DEDUCTION:** Deduction of Income Tax shall be made from any amount payable to the Contractor as per the relevant provisions of the Income Tax Act.
- **4.51** TDS UNDER GST LAW: As per GST Notification No. 50/2018 dated 13.09.2018, TDS @ 2% will be deducted from any amount payable to the Contractor, where the total value of contract is more than ₹ 2.5 lakhs.

4.52 ACCEPTANCE OF TERMS & CONDITIONS:

It shall be deemed that excepting those conditions stipulated by the tenderer which vary from the conditional laid down by the Port in all the above schedule, the tenderer is agreeable to and abide by all the other conditions, specifications etc, stipulated in the tender documents even though no specific mention thereof made in the tender. The conditions stipulated by tenderer will be considered as deviations and may or may not be accepted.

- **4.53 AWARD OF CONTRACT**: The V.O. Chidambaranar Port Authority shall award the contract to the tenderer whose offer is substantially responsive to the tender document and has been determined to be the lowest evaluated tender.
- **4.54 NOTIFICATION OF AWARD**: Prior to expiry of tender validity or extended validity, the V.O. Chidambaranar Port Authority shall notify the successful tenderer, in writing, that his tender has been accepted. Until a formal contract is

- prepared and executed, the notification of award and form of tender shall constitute a binding contract.
- **4.55 INSURANCE**: Labour and materials for the work at V.O. Chidambaranar Port Authority (Site) shall be insured at his own cost and the Port will no way be responsible for the loss/damages to the materials in connection with reconditioning of the buoys, testing, warranty repairs etc.
- 4.56 <u>ALTERATIONS AND ADDITIONS</u>: Should any alterations or additions in the subject work as specified in the said specifications not involving extra cost to the contractor be considered necessary or expedient by either party and be mutually agreed or in writing, the contractor shall execute the same without any charge beyond the contract price. But if the Port desires any alterations or additions involving extra cost to the Contractor, the Contractor before executing the same, arrive at a mutual agreement regarding the cost and time for such alterations and additions.
- 4.57 <u>REJECTIONS AND REPLACEMENTS</u>: All material and workmanship used and employed in carrying out this contract shall be to the entire satisfaction of the V.O. Chidambaranar Port Authority. Any portion of equipment /material or any of the works done under this contract which may be considered to be defective or unsatisfactory or not in accordance with the said specifications shall be rejected by V.O. Chidambaranar Port Authority and shall be replaced to the satisfaction of V.O. Chidambaranar Port Authority at the sole expense of the Contractor.

4.58 QUALITY OF MATERIALS AND WORKMAN SHIP:

All the equipment/materials, components, accessories etc. used shall be brand new and readily available. All items offered shall be as per approved quality and standards. They shall be of such design, size and material as to function satisfactorily under the rated conditions of operation and to withstand the environmental conditions at site. The contractor shall supply the equipment/material according to the true intent and meaning of the specifications of the contract and complete the same to the entire satisfaction of the V.O. Chidambaranar Port Authority.

SECTION: 5

- c. Fabrication of 2 numbers man hole door 600mmx500mm oval shape 8mm thick MS Plate with rubber packing and 12mm, 2inches length SS bolts and nuts with washer 16 numbers..
- d. Fabrication of top and bottom fender holding plate circumference of 8293.8mm x 80mmwidth x 8mm thick plate, 8 segments. D-Fender base doubler plate 8mm plate, 6inch width, circumference 8293.8mm MS Plate.
- e. 6x6inches D-fender 1 metre length 9 numbers renewal.
- f. 12mm, 8 inches SS bolt and nut with washer 50 numbers for fender holding.
- g. 10inch D-shackle for chain linking 10 numbers.
