V.O.Chidambaranar Port Authority, Tuticorin invites e-Tenders from the bidders fulfilling the Minimum Qualifying Criteria for pre-qualification as stipulated in the bid document for the work of “**Cleaning the garbages around Administrative office area, by sweeping, collection, conveyance and disposal for a period of Two years (2024-2026) in V.O.C Port**”.

1	Estimates cost put to tender	Rs.1,13,64,120/- (Rupees One Crore, Thirteen Lakhs, Sixty Four Thousand One Hundred and Twenty only)
2	Earnest Money Deposit (EMD)	Rs.2,27,285/- (Rupees Two Lakhs, Twenty Seven thousand, Two Hundred and Eighty Five only) EMD payment by the bidders should be only through online payment gateway mode. Otherwise, his/her/their tender will be rejected.
3	Contract period	Two Years (extendable further upto one year)

2.Minimum Qualifying Criteria

The bidder should have successfully completed similar work/services during the last Three years ending up to **31st, May,2024** with either of the following in any Central/State Government/Autonomous bodies/PSEs/PSU / Nationalized Banks / Public Limited or Private Limited Companies, etc.

- i) **One** similar completed work/services each costing not less than **Rs.90,91,296/-**
(or)
- ii) **Two** similar completed work/services each costing not less than **Rs.56,82,060/-**
(or)
- iii) **Three** similar completed work /services costing not less than **Rs.45,45,648/-**

The above said details shall be furnished by the bidder in the **Form IV of Annexure A**.

Note:

- i) Similar work/ services means the Contractor should have **completed Sweeping (or) Cleaning works by deploying labourers** at any Central / State Government / Autonomous bodies / PSEs/PSUs / Nationalized Banks / Public Limited or Private Limited Companies, etc.
- ii) The work experience shall be considered as per the Performance Certificate (or) Completion Certificate issued for the works furnished against the Minimum Qualifying Criteria.
- iii) In case of experience other than Central / State Government / Autonomous bodies / PSEs/PSUs/ Nationalized Banks / Public Limited Companies, the bidder has to submit TDS certificate for the past experience, only then the experience will be considered.
- iv) Only the documents stated in **Form III** and **Form IV** of **Annexure A** shall be considered for evaluation and any other documents uploaded but not stated in the above mentioned **Form III** and **Form IV** of **Annexure A** shall not be considered for evaluation.
- v) In case of MSME bidders the prior experience in terms of monetary value in Manpower tender shall be as follows:
 - i. For 1 work instead of 80% of put to tender value, it shall be 20% of 80% (i.e) 16%
 - ii. For 2 works instead of 50% of put to tender value, it shall be 20% of 50% (i.e) 10%
 - iii. For 3 works instead of 40% of put to tender value, it shall be 20% of 40% (i.e) 8%

3. Financial Capability:

Average Annual financial turnover during the last three years, **(2020-21, 2021-22 & 2022-23)** ending 31st March,2023 the previous financial year, should be not less than **Rs.34,09,236/-**

The details shall be furnished by the bidder in the **Form III of Annexure A**.

4. General Conditions:

- 1. The tender documents and other relevant documents are required to be submitted only through e-tender mode offered in the website **<https://etenders.gov.in/eprocure/app>**.
- 2. The e-Tender will not be considered who have ongoing litigation against the VOCPA.
- 3. Tenders which are in any way incomplete will not be considered.

4. VOCPA reserves the rights to waive any formality there of or to reject any or all the tenders without assigning any reason and not bound itself to accept the lowest tender.
5. The tenderer while uploading their document shall ensure to upload the undertaking in the company's letter head as per **Annexure-E** (Tender Acceptance Letter) of Tender document instead of uploading of signed tender documents failing which, the offer will not be considered for evaluation.
6. This Notice Inviting Tender shall form part of the contract agreement.

Note: The RTGS / NEFT or Bank Guarantee for the Performance Security shall be valid for the entire period (or) the extended period of the contract. The Performance Security will be released on successful completion of work.
