Sub: Filling up the post of Deputy Chief Vigilance Officer in the pay of scale of Rs. 60000-180000 in Vigilance Department, V.O.Chidamabaranar Port Authority on deputation method–reg.

Sir/Madam,

Applications are invited for filling up of the post of Deputy Chief Vigilance Officer (VG/DCV/01) in the Class I scale of pay of Rs.60000-180000 in Vigilance Department of V.O.Chidambaranar Port Authority by Deputation method from the eligible and willing Officers of Major Port Authorities, fulfilling the eligibility criteria prescribed in the Recruitment Rules for the said post. The copy of the Recruitment Rule is enclosed as Annexure-1.

- 2. The application through proper channel may be sent in a prescribed proforma enclosed as Annexure II along with the following documents in an envelope, super scribing "Application for the post of Deputy Chief Vigilance Officer in V.O.Chidambaranar Port Authority" so as to reach the office of the Secretary, V.O.Chidambaranar Port Authority, Administrative Building, Harbour Estate, Tuticorin 628 004, Tamil Nadu on or before 22.07.2024.
  - i. Photocopy of APARs of the applicant for the last 5 years, attested by an Officer not below the rank of Dy.HOD on each page. The selection is by 'Merit' for which overall grading in the APARs should not be below "Very Good". If APAR for a particular year is not available, last available APAR may be furnished with a "No Report Certificate" along with APARs of the preceding years.
  - ii. A statement showing year-wise availability of APARs and grading duly signed by the HOD / Secretary.

- iii. Attested photocopies of all certificates and proof of educational qualification, present and past work experience in the respective post and pay scale.
- iv. A self attested passport size photo of the candidate to be affixed on the application.
- v. No objection certificate from the respective Port.
- vi. Certificate by the Head of the Office of the applicant Annexure- III.
- vii. An Undertaking of the applicant not to withdraw his/her candidature, if selected by Service Selection Committee
- viii. Vigilance and Administrative clearance of the applicant is to be furnished in the format in Annexure-IV prescribed by the Ministry of Ports, Shipping & Waterways letter concerned Port, letter No.A-12022/10/2005-PE.I dated 27th August 2010, copy of which is attached.
- ix. The veracity of the qualification certificates and the recognition of the degree obtained by the applicant may be ensured and certified.
- x. If any major or minor penalty has been imposed on the applicant during the last 10 years, the disciplinary case leading to the penalty along with necessary documents may be sent by the forwarding authority along with the application.
- 3. Ministry vide letter dated 22/10/2021 has issued guidelines/advisory stating that all the matters relating to appointment / filling up the post of Dy.CVO's only in Major Port Authorities shall be dealt in the Vigilance Division of this Ministry by following the similar practice as in PHRD Division in respect of other Dy.HOD level posts.
- 4. The officer selected for the above post will be appointed on deputation basis and will be governed by the terms and conditions, prescribed by the Central Government. The Deputation will normally be for a period of 3 years and in any case, not to exceed 5 years.
- 5. The crucial date for determining the eligibility criteria will be the last date of closing of application ie. 22.07.2024. Applications received through proper channel will only be considered. Applications received after the last date / without ACRs / without enclosures, etc, will not be considered.

- 6. The applications duly forwarded within the due date shall only be considered. Hence, the Major Ports are requested to enclose all relevant documents at a time. No piecemeal / part forwarding will be considered.
- 7. Incomplete applications or applications received after due date will not be considered.
